- 3. Adjourn the Annual Meeting from time to time, as may be required.

All nominees have been submitted to the Director of the Missouri Department of Commerce and Insurance for approval, as required by law.

The Plan provides that other nominees may be submitted to the Board, but not less than 45 days prior to date of such Annual Meeting, upon the petition of 11 Member Insurers.
